

JHARKHAND LEGISLATIVE ASSEMBLY SECRETARIAT FIFTH (BUDGET) SESSION OF FOURTH JHARKHAND LEGISLATIVE ASSEMBLY

The Fifth (Budget) session of the 4th Jharkhand Legislative Assembly which commenced on 15th February, 2016 and was adjourned sine-die on 18th March, 2016. During the session period, the House sat for 23 days and transacted business for a period of approximately 67 hrs. and 20 minutes.

OPENING ADDRESS BY HON'BLE SPEAKER

The session commenced with the address by Hon'ble Speaker. Hon'ble Speaker welcome the members and apprised them about the business to be transacted during the session. Hon'ble Speaker concluded his address with the hope and faith for positive co-operation of the members in conducting the house.

GOVERNOR'S ADDRESS

This being the first Session of this year, His Excellency the Governor of Jharkhand Smt. Droupadi Murmu addressed the House at 11 A.M on 15th February, 2016 in pursuance of Article-176 (i) of the Constitution of India. After her departure, the House re-assembled and as per instruction of the Hon'ble Speaker, myself laid a copy of the Governor's Address on the Table of the House. House was informed by the Hon'ble Speaker that the members may present the amendment on the address of the Hon'ble Governor to the Secretary of Assembly till 03.00 p.m. today on date 15th February, 2016. The House discussed the Motion of Thanks for two days 16.02.2016 and 17.02.2016. The House adopted the motion of thanks on 17.02.2016.

FINANCIAL BUSINESS

On 16th February, 2016 the Finance Minister (Chief Minister) Shri Raghubar Das introduced the Third Supplementary expenses for the Financial year 2015-16, debate occurred on the Third Supplementary expense which was discussed on the 18th February, 2016. After the response of Government and vote on the appropriation bill, the bill was passed by the House on the same date. On 19th February, 2016 Finance Minister (Chief Minister) Shri Raghubar Das introduced the Budget for the Financial year 2016-17. On 23rd and 24th February, 2016, debate occurred on the budget. On 25th, 26th, 29th February, 01st, 02nd, 03rd, 04th, 08th, 09th, 10th, 11th, 14th and 15th March, 2016 debate occurred on the demands of the grants of budget expense which was discussed on the above said days. After the response of Government and vote on the appropriation bill, the bill was passed by the house on 15th March, 2016.

LEGISLATIVE BUSINESS (BILLS)

During the session, 12(Twelve) Bills were introduced, out of these 13 (Thirteen) Bills were passed, these are as follows:-

"The Jharkhand State University (Amendment)Bill, 2015" was introduced on 21st December, 2015. On request of Hon'ble Members under the consideration, the then Hon'ble Speaker refered to the aforesaid bill to the Select Committee and directed the select committee to submit its report within 15 days. After discussion the Select Committee submitted its report to the House. Then The Jharkhand State University (Amendment)Bill, 2016 was passed on 18th March, 2016 by the House.

The Jharkhand Registration of Marriage Bill, 2012 passed earlier by the House on 18th December, 2013 was sent for the assent of Hon'ble President of India under article 201 of the Constitution of India. The Ministry of Home Affairs, Government of India returned the said bill due to errors. On dated 01.03.2016 the Jharkhand Registration of Marriage Bill, 2012 was returned to the House by the Minister of Law according to the procedure and conduct of business of Jharkhand Legislative Assembly rules 110.

The Jharkhand Appropriation (No-01) Bill, 2016 was introduced and passed earlier by the House on 18th February, 2016. On 24th February, 2016 Hon'ble Governor of Jharkhand assent on above said bill under article 200 of the Constitution of India.On 01 March 2016, the above matter was informed to the House by the secretary of Jharkhand Legislative Assembly.

QUESTIONS

Notices of 764 nos. of Starred,143 nos. of Un-starred questions and 1210 nos. Short notice respectively had been received, out of these 1421 nos. & 143 nos. Notices were admitted as Starred and Un-starred questions and 220 Short notice respectively.

PRIVATE MEMBERS RESOLUTION

During the session, on 18th February, 2016 (Friday) was allotted for taking up Private members resolutions. Altogether 36 Resolutions were admitted, out of these 34 were accepted and returned.

CALLING ATTENTION

Total 148 notices were received and 92 notices were accepted and 01 was rejected, out of these, replies for 16 notices were received by the committee.

PETITIONS

09 notices of the petitions were received among them 06(six) petitions were admitted and presented in the House and rest of 03 notices were rejected.

ADJOURNMENT MOTION

During the session, 15th notices of Adjournment Motions were received but Hon'ble Speaker withheld there consent to all the Motions.

NIVEDAN

During the aforesaid session, 122 Nivedans were received, out of these 112 were admitted and sent to the concerned department for reply and rest 10 were rejected.

ZERO HOUR

Several issues of public interest were raised by the Hon'ble members in the House during the zero hour. In this session, 496 zero hour notices were received, out of these 484 notices were permitted to read.

Many policemen died on a bomb blast at Chatrapur-Japla road of Palamu near Kalipahari; Lt. Col. Niranjan Kumar and other Soldiers were killed in a terrorist attack. On 22-12-15 BSF Soldiers were killed in an aeroplane crash near Indra Gandhi International Airport, Some Soldiers were killed due to heavy ice-storm at Sciyachin Glacier, At Bagodar in the Giridih district total 11 persons were killed along with school children when a disbalanced vehicle ran over them; Murder of Vinay Kumar Mahto at

Sapphair International School, Ranchi and unfortunate death of P.A. Sangma, Ex. Speaker of Lok Sabha. In this matter great sorrow was expressed by the House after that Hon'ble Chief Minister Shri Raghubar Das, Hon'ble Leader of Opposition Shri Hemant Soren, Hon'ble Minister Shri Chandraprakash Choudhary, Hon'ble Members Shri Aalamgir Aalam, Pradeep Yadav, Rajkumar Yadav, and Smt. Geeta Kora also mourned. After that, the member stood in silence for a short while as mark of respect to the memory of the departed soul.

VALEDICTORY SPEECH

On 18th March,2016 at the conclusion of the Business of the session, the Hon'ble speaker made a valedictory speech before adjourning the House sine-die. In this speech ,he expressed his gratitude to the members of both the treasury, the opposition benches, officers and staff of the Assembly secretariat, Officers of different departments, police personnel, News agencies & Electronic media, Doordarshan and AIR etc. for conducting session and for their co operation during the session.

The whole session passed out peacefully. The House was adjourned sine-die by the Hon'ble Speaker Shri Dinesh Oraon after the conclusion of its sitting on 18th march,2016. The House was also propogued by His Excellency the Governor of Jharkhand on the same day.
